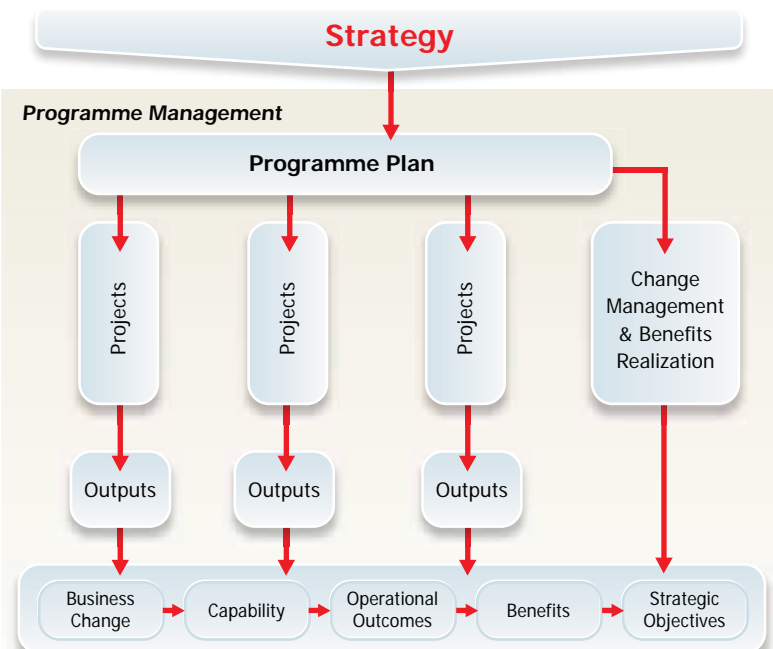
Benefits of Programme Management

Exam: The Practitioner examination is an open book objective test examination based on a given scenario and lasting 150 minutes. There are 9 questions each worth 20 marks, making a total of 180 marks. The pass mark is 50%.

MSP Advanced Practitioner

The aim of this course is to consolidate and add to the knowledge and experience gained in the MSP Practitioner course and prepare candidates for the Advanced Practitioner qualification.

Exam: The Advanced Practitioner examination is an open book essay type written examination based on a given scenario and lasting 150 minutes. There are 75 marks available. The pass mark is 50%. MSP Practitioner certification is a pre-requisite to the Advanced Practitioner certification.

At end of the Overview course participants will be able to:

- Realize the value and scope of MSP.
- Understand how programmes help deliver major change.
- Utilise key MSP terminology.
